### **UBAC RESOLUTION**

BACR No.: BACEq-15-2023

A RESOLUTION DECLARING TOYOTA ISABELA, INC. AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF ITEM NO. 1 OF PROJECT 2023-4E: SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLES FOR BOTH CAMPUSES

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2023-4E: Supply and Delivery of Various Motor Vehicles for Both Campuses with an Approved Budget for the Contract (ABC) amounting to Php11,000,000.00 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on June 14, 2023;

**WHEREAS**, in response to the said advertisement, Toyota Isabela, Inc. was the only prospective bidder that purchased the bidding documents;

WHEREAS, during the opening of eligibility and financial documents on July 4, 2023, the lone bidder passed the preliminary examinations as to legal documents presented and upon correction of the Net Financial Contracting Capacity (NFCC);

WHEREAS, while the Bid Amount of Toyota Isabela, Inc. was at Php10,824,000.00, only the offer for Item No. 1 "Motor Vehicle, Passenger Van, 2023 or latest model" with ABC of P1,800,000.00 was found eligible for the technical and financial bid;

WHEREAS, the offer for Item No. 1 was at Php 1,784,000.00;

WHEREAS, the offer Item No. 2 was beyond the ABC and the offer for Item No. 3 did not meet the specifications for the procurement project:

WHEREAS, during the Post Qualification on July 5, 2023, upon further examination and verification, the Technical Working Group (TWG) found out that the offer for Item No. 1 has a higher specification for the original intended use as "Utility Van;"

WHEREAS, the TWG recommended an on-site post qualification to further verify and confirm the offer of Toyota Isabela, Inc., on Item No. 1;

WHEREAS, on August 2, 2023, during the Post Qualification Conference of the BAC-Equipment, upon presentation of the TWG's findings, the members have agreed to accept the offer of Toyota Isabela, Inc. since the offer with higher specification would be more advantageous to the university;

**WHEREAS**, the end-user, Mr. George W. Bantasan, has also agreed to accept the offer of Toyota Isabela Inc.;

WHEREAS, during the said meeting, it was also decided that members and TWG will conduct on-site post qualification at Toyota Isabela, Inc, on August 3, 2023;

WHEREAS, on August 11, 2023, during the Emergency Meeting of the BAC-Equipment on the findings on the on-site post qualification, the TWG confirmed that the offer for Item No. 1 is the "Commuter Hi Ace Deluxe;"

WHEREAS, upon careful examination, verification, validation and ascertainment of all statements and representations made, including all documents submitted by the bidder, the bid of Toyota Isabela, Inc. for Item No. 1 has been found to be responsive;

**NOW, THEREFORE**, We, the Members of the University Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

1. Award item No. 1 in the project to Toyota Isabela, Inc as the bidder with the Single Calculated and Responsive Bid (SCRB) amounting to Php1,784,000.00;

2. Re-advertise the items No.2 and No.3 for Competitive Bidding; and

3. Recommend for approval by the University President the foregoing action.
