**RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) IN SOME ITEMS AND RECOMMENDING THE PROJECT FOR AWARD**

**WHEREAS**, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2024-09G: Supply and Delivery of Reference Books for the University Library - Bambang Campus with an Approved Budget for the Contract (ABC) amounting to Seven Hundred Eighty-Four Thousand Eight Hundred Seventy-Two pesos only (Php784,872.00) in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on March 12, 2024;
