WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for **Project 2024-02G: Procurement of One Year Subscription of Plagiarism Checker Program** with an ABC of **Six Hundred Fifty Thousand Pesos Only (Php650,000.00)** in the NVSU website, PhilGEPS portal, and conspicuous places in the premises of the NVSU on **February 15, 2024**;

WHEREAS, the said project, **Project 2024-02G: Procurement of One Year Subscription of Plagiarism Checker Program**, conducted its **Pre-Bid Conference** on **February 23, 2024** at the 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and there are some variations made.

WHEREAS, with the said variations, a **Supplemental Bid Bulletin (SBB)** was created with **SBB No. 2024-02G-001** and was posted on the NVSU website, PhilGEPS portal, and conspicuous places in the premises of the NVSU on **February 29, 2024**.


