RESOLUTION DECLARING AFA ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR PROJECT 2024 - 03G: PROCUREMENT AND FABRICATION OF VARIOUS FURNITURE AND FIXTURES (LOT 1 AND LOT 2) AND RECOMMENDING FOR ITS AWARD

WHEREAS, there is an approved **Purchase Request Numbers CN 24-01-145 and CN 24-01-145** with a total approved budget of **Four Million Four Hundred Thirty-five Thousand Seventy Pesos Only (Php4,435,070.00)** for the **Procurement and Fabrication of Various Furniture and Fixtures (Lot 1 and Lot 2)**;

WHEREAS, said items are included and conformed to the approved budget of the end user's Project Procurement Management Plan (PPMP) and the Nueva Vizcaya State University's (NVSU) Annual Procurement Plan (APP) for CY 2024;

WHEREAS, the Bids and Awards Committee conducted a **Pre-Procurement Conference** for the project **Procurement and Fabrication of Various Furniture and Fixtures (Lot 1 and Lot 2)** on **February 06, 2024** at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and it was discussed that the project shall be bid per lot and assigned as **Project 2024-03G**;

WHEREAS, the NVSU advertised and posted the Invitation to Apply for Eligibility and to Bid for the **Project 2024 - 03G: Procurement and Fabrication of Various Furniture and Fixtures (Lot 1 and Lot 2)** with an Approved Budget for the Contract (ABC) amounting to **Php4,435,070.00** in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on **February 15, 2024**;

WHEREAS, a Pre-Bid Conference was conducted on February 23, 2024 at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and upon discussion of the BAC, end-user and some prospective bidders, a Supplemental Bid Bulletin No. 2024-03G-002 was issued and was posted on February 29, 2024;

WHEREAS, in response to the aforementioned advertisement, two (2) prospective bidders purchased the bidding documents;

WHEREAS, on the last day of submission and receipt of bids on **March 6, 2024**, two (02) prospective bidders submitted bid envelopes which, namely: **AFA ENTERPRISES and ROEL'S FURNITURE**;

WHEREAS, during the opening of eligibility and financial documents on March 6, 2024, the aforementioned participating bidders passed the preliminary examinations as to legal/technical and financial documents and was found eligible wherein **AFA ENTERPRISES** has the Lowest Calculated Bid for **Project 2024-03G: Procurement and Fabrication of Various Furniture and Fixtures (Lot 1 and Lot 2)**;

WHEREAS, to conduct thorough verification and evaluation, the Bids and Awards Committee (BAC) - Goods and Services conducted an onsite evaluation through Project Verification and Evaluation Slip from the supplier's declared Single Largest Completed Contract (SLCC) - Talavera General Hospital, Talavera, Nueva Ecija on April 8, 2024 and site inspection of AFA Enterprises at Malayantoc, Sto. Domingo, Nueva Ecija.


