WHEREAS, there is an approved **Purchase Request Numbers TF (FF)-24-1-237 and TF (FF)-24-1-223** with a total approved budget of **Four Million Eight Hundred Thirteen Thousand Six Hundred Pesos Only (Php4,813,600.00)** for the **Supply, Delivery and Layouting of Yearbook and Pictorials for Graduating Class 2024;**

WHEREAS, said items are included and conformed to the approved budget of the end user's Project Procurement Management Plan (PPMP) and the Nueva Vizcaya State University's (NVSU) Annual Procurement Plan (APP) for CY 2024;

WHEREAS, the Bids and Awards Committee conducted a **Pre-Procurement Conference** for the project **Supply, Delivery and Layouting of Yearbook and Pictorials for Graduating Class 2024** on **February 06, 2024** at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and it was discussed that the project shall be bid per lot and assigned as **Project 2024-04G;**

WHEREAS, the NVSU advertised and posted the Invitation to Apply for Eligibility and to Bid for the **Project 2024 - 04G: Supply, Delivery and Layouting of Yearbook and Pictorials for Graduating Class 2024** with an Approved Budget for the Contract (ABC) amounting to **Php4,813,600.00** in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on **February 15, 2024;**

WHEREAS, a Pre-Bid Conference was conducted on February 23, 2024 at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and upon discussion of the BAC, end-user and some prospective bidders, a Supplemental Bid Bulletin No. 2024-04G-003 was issued and was posted on February 29, 2024;

WHEREAS, in response to the aforementioned advertisement, one (1) prospective bidder purchased the bidding documents;

WHEREAS, on the last day of submission and receipt of bids on **March 6, 2024**, only one (01) prospective bidder submitted bid envelopes which is **EHSON PUBLISHING;**

WHEREAS, during the opening of eligibility and financial documents on March 6, 2024, the aforementioned participating bidder passed the preliminary examinations as to legal/technical and financial documents and was found eligible;

WHEREAS, upon final post-qualification on April 4, 2024, involving the careful examination, validation, verification and ascertainment of all statements and representations made, including all documents submitted by the bidder with the Single Calculated Bid, its bid for the project has been found to be responsive;
