**WHEREAS**, the Bids and Awards Committee conducted a **Pre-Procurement Conference** for the project **Procurement of Hardware, Plumbing and Electrical Supplies for the University** on **April 02, 2024** at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and it was discussed that the project shall be bid per lot and assigned as **Project 2024-13G**;


**NOW, THEREFORE**, We, the Members of the University Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:
