**RESOLUTION DECLARING ANGLOWEALTH ENTERPRISES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROJECT 2024-05G: PROCUREMENT OF SUPPLIES AND MATERIALS FOR THE GRADUATION 2024 AND RECOMMENDING FOR ITS AWARD**

**WHEREAS**, the Bids and Awards Committee conducted a **Pre-Procurement Conference** for the project **Procurement of Supplies and Materials for the Graduation 2024** on **February 06, 2024** at 3/F Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya and it was discussed that the project shall be bid per lot and assigned as **Project 2024-05G**;


