Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending the Project for Award to A&J DESIGNS AND CONSTRUCTION

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2024-08i: Completion of Business Stalls and Classrooms for Bambang Campus**, with an Approved Budget for the Contract (ABC) amounting to Php15,137,000.00 in the NVSU website, the PhilGEPS, Social Media, and conspicuous places in the premises of the NVSU on June 18, 2024;

WHEREAS, the Pre-Bid Conference and Opening of Bids were scheduled on June 26, 2024 and July 8, 2024 respectively;

WHEREAS, in response to the said advertisement, three (03) bidders bought the bidding documents, to wit:

1. A&J DESIGNS AND CONSTRUCTION;
2. J3MS CONSTRUCTION; and
3. D&D ENGINEERING SERVICES, CO.;

WHEREAS, on the scheduled deadline of submission and receipt of bids dated July 8, 2024 at 9:00AM, all the prospective bidders submitted bid envelopes;

WHEREAS, during the opening of eligibility and financial documents, all the bidders passed the preliminary examinations as to legal/technical and financial bids, and were found eligible on July 8, 2024;
