RESOLUTION DECLARING AJG SECURITY AGENCY CORPORATION HAVING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR PROJECT 2024-06G: PROVISION OF SECURITY AND PROTECTION SERVICES FOR BOTH CAMPUSES AND RECOMMENDING IT FOR AWARD

WHEREAS, the Nueva State University advertised and posted the Invitation to Apply for Eligibility and to Bid for **Project 2024-06G: Provision of Security and Protection Services for both Campuses** with an **Approved Budget for the Contract (ABC) amounting to Eight Million Three Hundred Twenty-Three Thousand pesos (Php8,323,000.00)** in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on February 27, 2024;

| 3. ULTRA SECURITY SERVICES, INC. | Failure to comply with Section 32.2.1 of the IRR of RA9184; and Failure to comply with Section 9 of Republic Act 11917 as the law governing Private Security Agencies (PSAs). |

WHEREAS, CARLOMAXIMUS SECURITY AGENCY, INC. and ULTRA SECURITY SERVICES, INC. filed their respective Motion for Reconsideration, both of which were denied by the BAC members. Both bidders were timely notified of such denial;

WHEREAS, on June 19, 2024, BAC members, Engr. Keziah Ann D. Rosini and Atty. Claudine Joy F. Abalos, conducted a project validation and evaluation at the Bank of Makati (BMI) as one of the on-going projects of AJG Security Agency Corporation, and an outstanding rating and positive remarks were given for the said security provider;

WHEREAS, on June 24, 2024, the Bids and Awards Committee (BAC) – Technical Working Group (TWG) conducted post-qualification activity, and the bid of AJG Security Agency Corporation was found eligible;

WHEREAS, the BAC convened on June 26, 2024, upon careful examination, verification, validation and ascertainment of all statements and representations made, including all documents submitted by the bidder with the 4th Lowest Calculated Bid in the project, its bid is found responsive;

WHEREAS, on June 27, 2024, the Bids and Awards Committee (BAC) sent a project verification and evaluation slip thru e-mail to City Government of Butuan as the Single Largest Completed Contract indicated in the bidding documents and one of the on-going projects of AJG Security Agency Corporation. RESOLVED, at Nueva Vizcaya State University – Bayombong Campus, Bayombong, Nueva Vizcaya, this 10th day of July 2024.


