Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending the Project for Award to D&D ENGINEERING SERVICES, CO.

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project 2024-11i: Improvement of the Sports Complex of the Nueva Vizcaya State University Bambang Campus, with an Approved Budget for the Contract (ABC) amounting to Php10,400,000.00 in the NVSU website, the PhilGEPS, social media, and conspicuous places in the premises of the NVSU on August 16, 2024;

WHEREAS, the Pre-Bid Conference and Opening of Bids were scheduled on August 27, 2024 and September 9, 2024 respectively;

WHEREAS, in response to the said advertisement, two (02) bidders bought the bidding documents, to wit:

- 1. D&D ENGINEERING SERVICES, CO.; and
- 2. BGS INFRATECH CONSTRUCTION

WHEREAS, on the scheduled deadline of submission and receipt of bids dated September 9, 2024 at 9:00AM, all the prospective bidders submitted bid envelopes;

WHEREAS, during the opening of eligibility and financial documents, all the bidders passed the preliminary examinations as to legal/technical and financial bids, and were found eligible on September 9, 2024;
