RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE PROJECT 2024-15G: SUPPLY AND DELIVERY OF PERSONALIZED MERCHANDISE FOR AWARD TO AREVALO CONSTRUCTION SUPPLY AND GENERAL MERCHANDISE

WHEREAS, there is an approved Purchase Request No. AF-24-01-27 under Auxiliary Fund with a total approved budget of **One Million Four Hundred Sixty-Two Thousand Seven Hundred Fifty Pesos Only (Php1,462,750.00)** for the supply and delivery of **Merchandising Project of the University**;

WHEREAS, said items are included and conformed to the approved budget of the end user's Project Procurement Management Plan (PPMP) and the Nueva Vizcaya State University's (NVSU) Annual Procurement Plan (APP) for CY 2024;

WHEREAS, the Pre-bid Conference and Opening of Bids of the project were scheduled on August 28, 2024 and September 9, 2024 respectively;
