

Resolution Recommending for the Approval of the Annual Procurement Plan (APP) FY 2025 by the Board of Regents (BOR)

WHEREAS, the University Bids and Awards Committee (UBAC) is mandated by Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" to prepare the Annual Procurement Plan (APP) to be approved by the Head of the Procuring Entity (HOPE);

WHEREAS, Section 14.1 (i) of the Revised Implementing Rules and Regulation (IRR) of RA9184 provides that the BAC Secretariat is tasked to consolidate the Project Procurement Management Plans (PPMPs) from various units of the Procuring Entity to make them available for review as indicated in Section 7 of this IRR and prepare the APP;

WHEREAS, the Higher Education Services (HES), Advance Education Services (AES), Research and Extension Training (RET), General Administrative and Support Services (GASS), Office of the President (OP), Administrative Management Services (AMS), Financial Management Services (FMS), Physical Plant and Site Development Services (PPSDS), and Auxiliary Services submitted the Project Procurement Management Plans (PPMPs) from various funds (F101, F164, F161, F163, F184) to the Budget Officer for evaluation and ensure that the amount indicated in the APP for FY2025 is consistent with the approved budget for FY 2025;

WHEREAS, the Budget Officer after careful evaluation, forwarded the PPMPs for FY2025 to the BAC Secretariat for consolidation;

WHEREAS, the University Bids and Awards Committee (UBAC) with the assistance of the Technical Working Group for Goods and Services, Infrastructure and Consultancy Services, after careful review, resolved to recommend for approval the Annual Procurement Plan for FY2025 chargeable to various funds;
