**Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and
 Recommending the Project for Award to DIAMOND J BUILDERS**

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2025-01i: Construction of Two Storey Forestry Building for Bayombong Campus**, with an Approved Budget for the Contract (ABC) amounting to Php24,650,000.00 in the NVSU website, the PhilGEPS, social media, and conspicuous places in the premises of the NVSU on December 9, 2024;

WHEREAS, the Pre-Bid Conference and Opening of Bids were scheduled on December 17, 2024 and January 3, 2025 respectively;


