RESOLUTION DECLARING FAILURE OF BIDDING FOR PROJECT 2025-02G: SUPPLY AND DELIVERY OF VARIOUS SEMI-EXPENDABLE OFFICE EQUIPMENT FOR THE UNIVERSITY AND RECOMMENDING THE PROJECT FOR RE-ADVERTISEMENT THROUGH COMPETITIVE BIDDING

WHEREAS, there is an approved Purchase Request No. CN-25-01-7 under General Fund (F101) and Trust Fund (F164) with a total approved budget of Five Million Two Hundred Fifty-Eight Thousand Six Hundred Ten and 50/100 Only (Php5,258,610.50) for the supply and delivery of various semi-expendable office equipment for the University;

WHEREAS, said items are included and conformed to the approved budget of the end user's Project Procurement Management Plan (PPMP) and the Nueva Vizcaya State University's (NVSU) Annual Procurement Plan (APP) for CY 2025;

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Goods, Services and Consultancy has advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2025-02G: Supply and Delivery of Various Semi-Expendable Office Equipment for the University, a line-item project, with an Approved Budget for the Contract (ABC) amounting to Php5,258,610.50 in the NVSU website, NVSU Facebook Page, PhilGEPS portal, and conspicuous places in the premises of the NVSU on December 5, 2024;

WHEREAS, the Pre-bid Conference and Opening of Bids of the project were scheduled on December 13, 2024 and December 26, 2024 respectively;

WHEREAS, the Philippine Bidding Documents (PBD) of the project were made available for the period of December 5, 2024 to December 26, 2024 at 8:59AM;

WHEREAS, in response to the said advertisement, only one (01) prospective bidder has purchased the bidding documents, specifically:

WHEREAS, during the scheduled opening of bids on December 26, 2024, the lone bidder did not drop bid envelope;
