**RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB)
 AND RECOMMENDING THE PROJECT FOR AWARD**

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2025-1E: Supply and Delivery of Laboratory Equipment and Machinery for the University with an Approved Budget for the Contract (ABC) amounting to Ten Million Twelve Thousand Three Hundred Eighty-Six pesos & 92/100 only (Php10,012,386.92) in the NVSU website, the PhilGEPS, Social Media and conspicuous places in the premises of the NVSU on December 5, 2024;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased the bidding documents.

WHEREAS, during the opening of eligibility and financial documents, the participating bidder passed the preliminary examinations as to legal/technical and financial bids and was found eligible on December 26, 2024;
