Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending the Project for Award to D & D ENGINEERING SERVICES, CO.

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2024-14i: Improvement of University Gymnasium for Bayombong Campus**, with an Approved Budget for the Contract (ABC) amounting to Php10,000,000.00 in the NVSU website, the PhilGEPS, social media, and conspicuous places in the premises of the NVSU on November 29, 2024;

WHEREAS, the Pre-Bid Conference and Opening of Bids were scheduled on December 6, 2024 and December 18, 2024 respectively;

WHEREAS, in response to the said advertisement, three (03) bidders bought the bidding documents, to wit:

1. BELONGINGS CONSTRUCTION SERVICES;
2. D & D ENGINEERING SERVICES, CO.; and
3. HJM CONSTRUCTION

WHEREAS, on the scheduled deadline of submission and receipt of bids dated December 18, 2024 at 9:00AM, all the prospective bidders submitted bid envelopes;

WHEREAS, during the opening of eligibility and financial documents, only two (02) bidders passed the preliminary examinations as to legal/technical and financial bids, and were found eligible on December 18, 2024 and one (01) prospective bidder failed due to non-submission of list of major equipment and Omnibus Sworn Statement attached is for a different project;

- b. recommend for approval by the University President the foregoing action.







