



RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR PROJECT 2025-07G: SUPPLY AND DELIVERY OF MEDICAL SUPPLIES FOR THE UNIVERSITY

WHEREAS, there are approved Purchase Requests with Purchase Request Numbers CN-25-01-16; TF(FF)-25-01-54; TF(FF)-25-01-57 and TF(FF)-25-01-203 respectively with a total approved budget of **One Million Eight Hundred Thirty-Nine Thousand Eight Hundred Twenty-Five Pesos and 90/100 Only (Php1,839,825.90)** for the **Supply and Delivery of Medical Supplies for the University**;

WHEREAS, said items are included and conformed to the approved budget of the end users' Project Procurement Management Plan (PPMP) and the Nueva Vizcaya State University's (NVSU) Annual Procurement Plan (APP) for CY 2025;

WHEREAS, the NVSU through the BAC advertised and posted the Invitation to Apply for Eligibility and to Bid for Project **2025-07G: Supply and Delivery of Medical Supplies for the University**, a by lot project, with an Approved Budget for the Contract (ABC) amounting to Php1,839,825.90 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on March 19, 2025;

WHEREAS, a Pre-Bid Conference and Opening of Bids were conducted on March 27, 2025 and April 8, 2025 respectively;

WHEREAS, in response to the aforementioned advertisement, six (6) prospective bidders purchased the bidding documents;

WHEREAS, during the opening of eligibility and financial documents on April 8, 2025, one (01) bidder was rated failed due to the submission of Price Schedule not in the prescribed form, while five (05) bidders passed the preliminary examination as to legal, technical, and financial documents and were found eligible;
