

A RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD OF CONTRACT FOR CERTAIN ITEMS, AND RETURNING NO BID ITEMS TO END-USER FOR MANDATORY REVIEW AND MARKET STUDY

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2025-1E: Supply and Delivery of Various Laboratory Equipment and Machinery for the University (Second Advertisement) with an Approved Budget for the Contract (ABC) amounting to Nine Million Six Hundred Thirty Thousand Eight Hundred Eighty Six pesos and 92/100 only (Php 9,630,886.92) in the NVSU website, the PhilGEPS, Social Media and conspicuous places within the NVSU premises on March 26, 2025;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased the bidding documents.

WHEREAS, during the opening of eligibility and financial documents, the participating bidder passed the preliminary examinations as to legal/technical and financial bids and was found eligible on April 15, 2025;

- a. declare **MEDWISE PHARMACY** as having the Single Calculated and Responsive Bid (SCRB) for the project;
- b. recommend award of contract for item nos. 1, 9, 13, 16, 19, 21, 26, 37, and 54 with a total bid of **Seven Hundred Eighty Thousand pesos only (Php780,000.00)** to Medwise Pharmacy;
- c. recommend the return of all NO BID ITEMS for item nos. 2-8, 10-12, 14-15, 17-18, 20, 22-25, 27-36, 38-53, and 55 with a total amount of Php8,698,286.92 to the end-user for the conduct of a mandatory review of the technical specifications and to undertake a market study on prevailing prices and thereafter, to resubmit the same to the BAC for processing through Public Bidding; and
- d. recommend for approval by the University President the foregoing action.
