RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRD) IN

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2025 - 6E: Supply and Delivery of Laboratory Supplies and Equipment for Upgrading the Citrus Diagnostic and Indexing Facility of the University, with an Approved Budget for the Contract (ABC) amounting to Four Million Pesos Only (Php4,000,000.00) in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on March 26, 2025;

WHEREAS, Project 2025 - 6E: Supply and Delivery of Laboratory Supplies and Equipment for Upgrading the Citrus Diagnostic and Indexing Facility of the University can be bid per line item;

WHEREAS, during the opening of eligibility and financial documents, the participating bidder passed the preliminary examinations as to legal/technical and financial bids and was found eligible on April 15, 2025;
