

**Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and
Recommending the Project for Award to DIAMOND J BUILDERS**

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee-Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2025-03i: Establishment of University Radio Station**, with an Approved Budget for the Contract (ABC) amounting to Php4,000,000.00 in the NVSU website, the PhilGEPS, social media, and conspicuous places in the premises of the NVSU on May 28, 2025;

WHEREAS, the Pre-Bid Conference and Opening of Bids were scheduled on June 5, 2025 and June 17, 2025 respectively;

- b. recommend for approval by the University President the foregoing action.






