- 2. The Nueva Vizcaya State University now invites bids for the above Procurement Project. Completion of the Works is required by Ninety (90) calendar days for cluster 1 and One Hundred Fifty (150) calendar days for cluster 2. Bidders should havecompleted within two (02) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rulesand Regulations (IRR), otherwise known as the "New Government Procurement Act (NGPA)".
  - i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
