

INVITATION TO BID FOR Project 2021-21: Provision of Security and Protection for Both Campuses

- 1. The Nueva Vizcaya State University, through the General Fund (GF) and Special Trust Fund (STF) FY 2021 intends to apply the sum of Php8, 424,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for 2021-21: Provision of Security and Protection for Both Campuses. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NVSU now invites bids for the above Procurement of Security Services. Delivery of the Goods/Services is required by Seven (7) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within three (03) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Interested Bidders may obtain further information from *Nueva Vizcaya State University BAC* and inspect the Bidding Documents at the address given below during *Mondays-Fridays from 8:00AM-5:00PM*.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting on *June 11, 2021* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php10,000.00.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *through electronic means*.
- 6. The Nueva Vizcaya State University will hold a Pre-Bid Conference¹ on June 21, 2021, 9:00AM at the Board Room, New Administration Building, NVSU Bayombong Campus and through video conferencing or webcasting via Zoom, which shall be open to prospective bidders. To reduce the risks and hazards of community transmission of

COVID-19, the BAC shall conduct meetings and conferences via **ZOOM** (Meeting ID: 299 724 9671, Password: nvsu@2021) until further notice, or until such time that the state of calamity, or implementation of community quarantine or similar government restrictions shall have been lifted by the proper governmentauthorities.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before July 5, 2021 at 8:59am or courier submission on the same address on or before July 2, 2021 at 5:00pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *July 5, 2021, 9:00am* at the given address and via **ZOOM** (Meeting ID: 740 058 1735, Password: nvsu@2021). Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.

- 8. Submission of Bid Envelopes by the bidder's representative must be accompanied by an authorization through a Special Power of Attorney (SPA)
- 9. The *NVSU* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bid
