Resolution Declaring LCRB and Recommending the Project for Award

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for 2023-10G Supply, Delivery & Lay-outing of Yearbook and Pictures for Graduating Class 2023 of Bayombong Campus with an ABC of (Php 3,300,000.00) in the NVSU website, PhilGEPS portal, and conspicuous places in the premises of the NVSU on May 4, 2023;

WHEREAS, in response to the said advertisement, two (2) prospective bidders purchased the bidding documents. During the opening of eligibility and financial documents, only one (1) of the participating bidders passed the preliminary examinations as to legal/technical and financial bids and was found eligible on *May 25, 2023*;

WHEREAS, the other bidder was not able to provide the eligibility to bid Item number 4: NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank and technical document # 7: Conformity with technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents that is why the BAC Member decided to mark it failed.
