



Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending the Project for Award to RDJD Construction.

WHEREAS, the Nueva Vizcaya State University through the University Bids and Awards Committee for Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2023-16i: Improvement/Repair of CAS Building for Bambang Campus**, with an Approved Budget for the Contract (ABC) amounting to Php708,696.00 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on August 8, 2023;


