**Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and
 Recommending the Project for Award to RDJD Construction**

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2023-17i: Improvement/Repair of Existing Boy's Dormitory for Bambang Campus**, with an Approved Budget for the Contract (ABC) amounting to Php2,910,000.00 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on August 8, 2023;

WHEREAS, the Pre-bid Conference and Opening of Bids were scheduled on August 16, 2023 and August 29, 2023 respectively;

WHEREAS, in response to the said advertisement, eight (08) prospective bidders bought the bidding documents namely: CJN Design and Construction Services, RM Domingo, EVPS Construction, A&J Designs and Construction, YZK Builders, Kurt Construction and Supply, RJC Construction Builders, and RDJD Construction;

WHEREAS, during the opening of eligibility and financial documents, the five (05) bidders passed the preliminary examinations as to legal/technical and financial bids and were found eligible on August 29, 2023;


