Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending the Award of Project to Tamrhey Construction

WHEREAS, the Nueva Vizcaya State University through the Bids and Awards Committee–Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project 2023-09i: Construction of Campus Drainage System Flood Control at Bayombong Campus and Road Network, with an Approved Budget for the Contract (ABC) amounting to Php2,207,853.51 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on June 5, 2023;

WHEREAS, the Pre-bid Conference and Opening of Bids were scheduled on June 13, 2023, and June 26, 2023 respectively;

WHEREAS, during the opening of eligibility and financial documents, all the bidders passed the preliminary examinations as to legal/technical and financial bids and were found eligible on June 26, 2023;

WHEREAS, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted by Tamrhey Construction as the bidder with the Lowest Calculated Bid (LCB), its bid has been found to be responsive for the reason stated below;
