WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2023-12i: Construction of Two Storey Business Stall for Bambang Campus**, with an Approved Budget for the Contract (ABC) amounting to Php11,640,000.00 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on June 5, 2023;

WHEREAS, the Pre-bid Conference and Opening of Bids were scheduled on June 13, 2023 and June 26, 2023 respectively;

WHEREAS, in response to the said advertisement, four (04) prospective bidders bought the bidding documents namely: RJC Construction Builders, N-J Construction, A&J Designs and Construction, and RDJD Construction;

WHEREAS, during the opening of eligibility and financial documents, the three (03) bidders passed the preliminary examinations as to legal/technical and financial bids and were found eligible on June 26, 2023;

- recommend for approval by the University President the foregoing action.


