WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2023-08G: Supply and Delivery of Consumables for Both Campuses (Negotiated Procurement – No Bid Items) with an Approved Budget for the Contract (ABC) amounting to Php216,095.03 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on August 23, 2023;
