
NOW, THEREFORE, We, the Members of the University Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

RESOLVED, at the NVSU Bayombong Campus, Bayombong, Nueva Vizcaya, this 8th day of January 2024.


