**Resolution Declaring 2nd Lowest Calculated and Responsive Bid (LCRB) and
 Recommending the Project for Award to D & D Engineering Services, Co.**

WHEREAS, the Nueva Vizcaya State University through the University Bids and Awards Committee for Infrastructure advertised and posted the Invitation to Apply for Eligibility and to Bid for project **2024-05i: Improvement of Guest House for Bayombong Campus**, with an Approved Budget for the Contract (ABC) amounting to Php4,866,812.00 in the NVSU website, the PhilGEPS, Social Media, and conspicuous places in the premises of the NVSU on June 18, 2024;

WHEREAS, in response to the said advertisement, seven (07) bidders bought the bidding documents, to wit;

WHEREAS, on the scheduled deadline of submission and receipt of bids dated July 8, 2024 at 9:00 am, all the prospective bidders submitted bid envelopes;

WHEREAS, during the opening of eligibility and financial documents, all the bidders passed the preliminary examinations as to legal/technical and financial bids, and was found eligible on July 8, 2024
