A RESOLUTION GRANTING THE REQUEST FOR RECONSIDERATION OF TOPCOMS MARKETING CORPORATION FOR THE PROJECT 2024-16G: PROVISION OF SEMI-EXPENDABLE SPORTS EQUIPMENT AND RECOMMENDING FOR AWARD OF CONTRACT

WHEREAS, the Nueva Vizcaya State University Bids and Awards Committee (UBAC) on Goods and Services has advertised and posted an Invitation to Apply for Eligibility and to Bid for the **Project 2024-16G: Provision of Semi-Expendable Sports Equipment** with an Approved Budget for the Contract (ABC) amounting to Three Million One Hundred Eighteen Thousand Six Hundred pesos only (**Php3,118,600.00**) in the NVSU website, Social Media, the PhilGEPS, and conspicuous places in the premises of the NVSU on **August 15, 2024**;

WHEREAS, a Supplemental Bid Bulletin No. 2024-08-001 was issued and was posted in PhilGEPS on August 20, 2024 to modify or amend items in the Bidding Documents which shall form an integral part of the Bidding Documents of the said project;

WHEREAS, a Pre-Bid Conference was conducted on August 28, 2024 at 3rd Floor, Board Room, New Administration Building, NVSU, Bayombong, Nueva Vizcaya. In response to the aforementioned advertisement, one (1) prospective bidder purchased the bidding documents;

WHEREAS, on the last day of submission and receipt of bids on **September 9, 2024**, only one (01) prospective bidder submitted bid envelope which is **TOPCOMS MARKETING CORPORATION**;

WHEREAS, during the opening of technical and financial documents on September 9, 2024, the aforementioned participating bidder passed the preliminary examinations as to technical and financial documents, and was found eligible;

WHEREAS, upon post-qualification, which involved the careful examination, validation, verification, and ascertainment of all statements and representations made, including the documents submitted by the bidder with the Single Calculated Bid, it was found however that the bid for the project was non-responsive due to non-compliance with the technical specifications for Item No. 37 (30 MM), specifically regarding the offered playing surface thickness of the table (25 MM);

WHEREAS, on October 9, 2024, the Bids and Awards Committee for Goods and Services (UBAC) has passed Resolution No. 2024-10-16G for the post-disqualification of TOPCOMS Marketing Corporation, and thereafter issued of a Notice of Post-disqualification for the aforementioned project on October 10, 2024 *via* email;

WHEREAS, a receipt of Notice of Post-disqualification was acknowledged on October 11, 2024 and a Motion for Reconsideration was submitted by the bidder on October 12, 2024;

WHEREAS, upon thorough review of the submitted explanations and supporting documents, including the product features, certifications and detailed justification, the BAC, in a meeting convened on October 17, 2024, unanimously agreed to grant the Request for Reconsideration of TOPCOMS Marketing Corporation;

RESOLVED, at the NVSU Bayombong Campus, Bayombong, Nueva Vizcaya, this 17th day of October 2024.


