RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) ON SOME ITEMS AND RECOMMENDING THE PROJECT FOR AWARD

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for Project 2023-19G: Supply and Delivery of Reference Books for the University (2nd Advertisement – No-Bid Items) Negotiated Procurement with an Approved Budget for the Contract (ABC) amounting to Php4,559,254.00 in the NVSU website, the PhilGEPS, and conspicuous places in the premises of the NVSU on July 2, 2024;

WHEREAS, Project 2023-19G: Supply and Delivery of Reference Books for the University (2nd Advertisement – No Bid-Items) Negotiated Procurement can be bid per line item;

WHEREAS, in response to the said advertisement, three (3) prospective bidders submitted their eligibility documents;

WHEREAS, on July 22, 2024, the last day of submission and receipt of bids, 3 prospective bidders submitted bid envelopes, CD BOOKS INTERNATIONAL, INC., WISEMAN’S BOOKS TRADING, INC., and F & J DE JESUS, INC.;

WHEREAS, during the opening of eligibility and financial documents on July 22, 2024 all the aforementioned participating bidders passed the preliminary examinations as to legal/technical and financial documents and were found eligible;
