Invitation to Bid

2020-11: IMPROVEMENT OF TECHNOLOGY LABORATORY BUILDING AND FACILITIES FOR BAMBANG CAMPUS

1. The *Nueva Vizcaya State University*, through the *General Fund for FY2020³* intends to apply the sum of *Php9,712,953.33* being the Approved Budget for the Contract (ABC) to payments under the contract for *2020-11 Improvement of Technology Laboratory Building and Facilities for Bambang Campus*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Nueva Vizcaya State University* now invites bids for *2020-11 Improvement of Technology Laboratory Building and Facilities for Bambang Campus*. Completion of the Works is required *360 calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Nueva Vizcaya State University* and inspect the Bidding Documents at the address given below from *Mondays to Fridays, 8:00AM to 5:00PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *December 7, 2019* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php10,000.00*.
