**Resolution Declaring Lowest Calculated and Responsive Bid
 and Recommending the Project for Award**

WHEREAS, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for the Project: **2020-11 Improvement of Technology Laboratory Building and Facilities for Bambang Campus** with an ABC of Php9, 712,953.33 in the NVSU website, the PhilGEPS, the NVSU UFM Radio and conspicuous places in the premises of the NVSU and some Municipal Offices of Nueva Vizcaya on December 7, 2019;

WHEREAS, in response to the said advertisement, eight (08) prospective contractors bought the bidding documents. During the opening of eligibility and financial documents, two (02) bidders did not submit bid envelope, one (01) bidder was rated Failed in the financial component of bid and the other five (05) bidders passed the preliminary examinations as to legal/technical and financial bids and were found eligible on December 31, 2019;


