INVITATION TO BID FOR *SUPPLY, DELIVERY AND INSTALLATION OF TECHNICAL & SCIENTIFIC EQUIPMENT FOR BAYOMBONG CAMPUS*

1. The *Nueva Vizcaya State University* through the *General Fund FY 2019* intends to apply the sum of *Php1, 256,500.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *2019-21 Supply, Delivery and Installation of Technical & Scientific Equipment for Bayombong Campus*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Nueva Vizcaya State University* now invites bids for *technical & scientific equipment*.¹ Delivery of the Goods is required *one hundred (100) calendar days upon receipt of the Notice to Proceed*. Bidders should have completed, within *two (02) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information to *Nueva Vizcaya State University* and inspect the Bidding Documents at the address given below during *Mondays to Fridays at 8:00AM-5:00PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *July 12, 2019* from the address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5, 000.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Nueva Vizcaya State University* will hold a Pre-Bid Conference² on *July 22, 2019, 9:00AM* at the *Mini Theater Conference Hall, Bayombong Campus, Bayombong, Nueva Vizcaya*, which shall be open to prospective bidders.

¹ A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

² *May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.*

7. Bids must be duly received by the BAC Secretariat at the address below on or before *August 5, 2019 at 8:59AM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.



8. *Submission of Bid Envelopes by the bidder's representative must be accompanied by an authorization through a Special Power of Attorney (SPA).*

The *Nueva Vizcaya State University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
