



**UBAC RESOLUTION NO. 2018- 57**  
**Resolution Declaring Lowest Calculated and Responsive Bid  
 and Recommending the Project for Award**

**WHEREAS**, the Nueva Vizcaya State University advertised and posted the Invitation to Apply for Eligibility and to Bid for the Infrastructure Project: **2018-36 Construction of Native Pig and Other Indigenous Poultry Building @ Singian, Tuao, Bagabag, Nueva Vizcaya** with an ABC of Php4, 021,679.00 in the NVSU website, the PhilGEPS, the NVSU UFM Radio and conspicuous places of the premises of the NVSU and some Municipal Offices of Nueva Vizcaya on October 23, 2018;

**WHEREAS**, in response to the said advertisement, six (06) prospective contractors purchased the bidding documents. During the opening of eligibility and financial check, two (02) bidders did not submit bid envelope, and the remaining four (04) bidders passed the preliminary examinations as to technical and financial bids and were found eligible on November 19, 2018;

**WHEREAS**, during the Opening of Bids, Southland Construction and Supplies has the Lowest Calculated Bid;

**WHEREAS**, the detailed evaluation conducted by BAC TWG-Infrastructures resulted in the following:





**NOW, THEREFORE**, We, the Members of the University Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:




